- Admission to the school is to be made restricted under rule 6.1 of Examination by laws and rule 12 (i, ii & iii) of Affiliation by laws.
- The school has to constitute a committee for protection of woman from sexual harassment at the work place and to abide by the guidelines and norms prescribed by the Hon'ble Supreme Court of India in W.P. Criminal No.666-70 of 1992 Vishaskha and other State of Rajasthan and other delivered on 13.8.1997 mentioned under rule no. 10.9.
- Each school affiliated/ to be affiliated with the Board shall frame Service Rules for its employees which will be as per Education Act of the state/U.T., if the Act makes adoption of the same obligatory, otherwise as per Service Rules given in Affiliation Bye Laws. Further, Service contract will be entered with each employee as per the provisions in the Education Act of the state/U.T., or as given in Appendix III, if not obligatory as per the State Education Act.
- Pay and allowances to staff should be revised time to time to bring it at par with that to State Government. Further, Salary and service conditions of staff should be provided i.a.w. rule no. 3.3 (v) and rule no. 10.2 as appended below;
  - a. The school in India must pay salaries and admissible allowances to the staff not less than the corresponding categories of employees in the State Covernment schools or as per scales etc. prescribed by the Government of India." - 17. Every secondary and senior secondary school shall appoint a person on full time basis for performing the duties of a Health Wellnes's teacher as per rule 53.5.
- Strict adherence to the provisions of Wild Life Protection Act while procuring plants and animals for the use in laboratories by the school must be made i.a.w. circular no 03 dated 21 May 2013.
- 19.
